



TEAR DOWN PROCEDURE

**IF IT DOESN'T SAY YOU CAN'T
IT DOESN'T MEAN YOU CAN!!!**

1. Tech Official decisions will be considered final, any abusive language or behaviour to Tech will result in penalties.
2. Any driver found illegal will lose all points and money won for that race event. He or she will be allowed to race again as long as he or she shows themselves legal to Management and Officials of the raceway. Any driver found illegal will have to run scratch position for four (4) race meets. If caught a second time he or she and the car will lose all points and money for the season. Any driver leaving after being told that he or she will be torn down will be assumed illegal and that night's money and points will be lost. All parts deemed illegal will be confiscated and returned after a successful appeal. Failure to submit parts for inspection – **AUTOMATIC DISQUALIFICATION!!**
3. Any race cars from other tracks will be permitted to run at South Buxton Raceway if the Raceway feels that they are close to our rules and they will be subject to a weight handicap and other restrictions that the Raceway feels proper.
4. No individual or representatives of any group will be recognized in any discussion or dispute unless they are a registered driver.
5. South Buxton Raceway has the right at any time to reject any component that it feels would add an expense to the class or an unfair advantage.
6. Amendments, revisions, and or clarifications may be made to the rules and procedures as circumstances may arise. Management has the right to refuse any protest if they feel it is being used for harassing reasons. All fines and other suspensions will be in effect at all race meets. The interpretation and invoking of the rules published herein will be determined by South Buxton Raceway Officials only in their professional discretion.
7. **PROTEST FORMS AND FEE**
As to tech only will be submitted by registered drivers on the lead lap in that class only and in cash only and must be submitted within five minutes of the end of their feature event to the Head of Tech.

NOTE: Any rule infringement is subject to disqualification! These rules indicate which is legal. If something does not appear legal or is questionable, it will be deemed NOT LEGAL! Final decisions will be solely that of the Management. Should something questionable be found to be legal by Management after investigation and after race meet, penalties imposed will be reversed.
